

**RESOLUTION OF THE DOBBINS/OREGON HOUSE FIRE PROTECTION DISTRICT
ESTABLISHING THE APPROPRIATIONS LIMIT FOR THE FISCAL YEAR 2025-2026
PURSUANT TO ARTICLE XIII B OF THE CALIFORNIA CONSTITUTION**

RESOLUTION 2025-05

WHEREAS, in accordance with Government Code Section 7910, Each year the governing body of each local jurisdiction shall, by resolution, establish its appropriations limit and make other necessary determinations for the following fiscal year pursuant to Article XIII B of the California Constitution at a regularly scheduled meeting or noticed special meeting.

WHEREAS the mission of the DOHFPD is to provide fire prevention, emergency response and emergency medical services throughout its boundaries; and

WHEREAS it is in the interest of the citizens and taxpayers of the Dobbins/Oregon House Fire Protection District, that the district utilizes the legally authorized funds available to it in providing improved fire protection and lifesaving and rescue services in the district; and

WHEREAS documentation used in determination of the Fiscal Year 2025-26 appropriations limit has been available to the public for at least 15 days prior to the date of this resolution, in accordance with Government Code Section 7910.

WHEREAS district assessments are calculated and levied based on the rate schedules adopted by the District Board and they are not levied based on the value of the customer's real property.

NOW, THEREFORE, BE IT RESOLVED by the Dobbins/Oregon House Fire Protection District, as follows:

1. That the foregoing statements are true and correct.
2. That the factors used to calculate the Fiscal Year 2025-26 appropriations limit are the percentage change in population of Yuba County times the percentage change in California per capita income for a composite change of 1.0689 applied to the Fiscal Year 2024-25 of \$368,391.00 to new established limit of \$391,357.00.
3. That the appropriations limit for the Dobbins/Oregon House Fire Protection District Fiscal Year 2025-26 pursuant to Article XIII B of the California Constitution is established at **\$391,357.00** and,
4. This appropriation limitation means the district cannot receive tax revenue during the year in excess of this amount nor can the district appropriate from taxes in excess of this limitation. Therefore, the limit is increased to **\$391,357.00** for the fiscal year 2025-26.
