Please keep in mind that retired United States Department of Agriculture (USDA) Forest Service vehicles are offered by the USDA Forest Service regional office through the FEPP Program, and not offered directly through National Forest Service locations.

Please let me know if any changes to the agreement need to be made and I will send you an amended version.

CAL FIRE, in conjunction with the USDA Forest Service, offers another excess property program called the Firefighter Property Program (FFP). In this program, certain acquired property can transfer ownership to the Dobbins-Oregon House Fire Protection District after one year in service. If participation in this program fits the needs of the Dobbins-Oregon House Fire Protection District, please let me know and I will provide further information.
